

## CALCIUM DELIVERY AGREEMENT 2024

**\*Please note that the deadline to register for 2024 calcium delivery is May 31, 2024.**

**In consideration of the Municipality of Boissevain-Morton (through its own public works crew and/or outside contractors) for the purpose of delivering calcium to residential property**

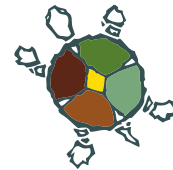

**NOW THEREFORE THIS AGREEMENT WITNESSES** that the Municipality and the Owner agree as follows:

1. The Municipality shall haul the ordered amount requested by the Owner at the current set rate, which is subject to change from year to year. The rate for **2024 is 35 cents per litre.**
2. The Owner represents that he/she is the owner or occupant of the said land and will ensure that the property is safe and accessible for the Municipality to access and deliver to.
3. The Owner agrees to indemnify and save harmless the Municipality in respect of any claims or demands which may at any time hereafter be brought against the Municipality or any employee of the Municipality performing the required work by any person, firm, or organization by reason of the performance of the required work. In addition, the Owner agrees to indemnify the Municipality and all of its representatives against all losses arising from my actions or omissions in respect of the subject matter of this Authorization.
4. The Owner understands that the total cost will be calculated based on the current set rate, the pass option requested, and the number of litres used on the property. All calcium ordered is final sale—there are no refunds. The Owner will receive an invoice following the calcium delivery and the bill will be due within 30 days. Any outstanding amounts will then be added to the Owner's property taxes bill.
5. The Owner acknowledges that the Municipality is not liable for any damages or additional costs incurred as the result of the service being provided.



6. The Owner agrees to have flags or stakes in place to mark where they would like the calcium dropped off (beginning and end points) if they wish. Otherwise, **if no flags/stakes are present, the drop-off site will be determined by and is at the discretion of the Municipality.**

As of 2019, the Municipality has been offering residents the option to register for automatic recurring delivery of calcium each year. If you sign up for this automatic recurring yearly delivery option, you will not need to fill out a registration form each year in order to have calcium delivered to your property. This new recurring service is optional. If you wish to continue to register each year for calcium delivery, you will still have that option. Please note that the Municipality will no longer be making phone calls each year for calcium. Once the public notice is sent out each spring, residents will be able to register for calcium delivery (for those who have not signed up for the automatic recurring service) by filling out a registration form from the Municipal Office. The form is available online at [www.boissevain.ca](http://www.boissevain.ca).

Therefore, we ask that you choose one of the following two options for calcium delivery to your property:

- One-Time Delivery:** I would like calcium delivered for **this year only** as per the above agreement. I understand that if I would like calcium delivered in future years that I will need to contact the Municipal Office to register each year for this service.
- Automatic Recurring Yearly Delivery:** I would like calcium delivered this year **AND** each year following as per the above agreement. I understand that I will be billed each year according to the set yearly rate which is subject to change, as are the dates for estimated delivery. If there are any changes required, or if I would like to end my automatic recurring yearly service, I will contact the Municipal Office immediately.

**\*2024 Calcium delivery is estimated to occur sometime first week of June and will be dependent upon weather and road conditions. Please have any flags or markers ready for this timeframe until the delivery has been received.**
